#### **Expression of Interest**

Central University of Jammu (CUJ) invites Expression of Interest **under two bid systems** from the interested parties to rent out suitable accommodations to the CUJ to establish the Temporary Boys Hostel of Central University of Jammu to accommodate approximately 100 Boys boarders. The building shall be hired initially for 01 year which can be extended on mutual consent.

#### The requirements are:

- 1. The Building/Buildings should accommodate approximately 100 Boys and should be near or within the radius of 15 km to CUJ Campus, Rahya Suchani, (minimum capacity of 25 or other options) Samba and accommodate 2 or 3 Boys students per room. It should have ventilated, airy rooms, in hygienic environment.
- 2. Ample number of bathrooms in good working condition must be provided.
- 3. The room should be filled with sufficient tubelight/LED light, fans and wardrobe.
- 4. Electricity and Potable Water for drinking and washing purposes must be available round the clock.
- 5. In emergency, power backup / generator facility should be available.
- 6. The building should have suitable provision and adequate space for running Mess for students.
- 7. The Service provider/ Building owner must provide document of Administrative Approval(s) of sanctioned Electricity load etc.
- 8. No commercial activity other than the Hostel will be carried out on the rented premises.
- 9. Selected party shall be required to execute a rent agreement containing detailed terms & conditions with CUJ, Jammu in accordance with the provisions of the law applicable.
- 10. The agreement shall be signed for a period of 01 year which may be extended on mutually agreed terms and conditions on the satisfactory report.
- 11. Building offered must be free from all encumbrances, claims and legal disputes etc.
- 12. The electricity and water supply lines / connection shall be provided by the owner at his/her own cost and expenses. However, the **CUJ**, **Jammu** shall pay all running charges with respect to electric power, light and water charges of the said premises on the basis of actual consumption.
- 13. The **CUJ** reserves the right to consider/reject any such proposal without assigning any reason. In case of rejection of application, the decision of competent authority will be final and binding and the party shall not be entitled to any compensation whatsoever for non issue of work.
- 14. The decision of the Competent Authority of CUJ will be final in case of any dispute arising in the implementation of the terms of the contract.
- 15. Service Maintenance charge should be mentioned, if any. CUJ will not pay any Holding Tax or dues for hired building.
- 16. The building should have been properly constructed as per the approved safety plans.
- 17. All property tax, all municipality tax, local taxes will be included in the rent. To Furnish details of such viz. Property tax, all Municipal Taxes and other Local Taxes being levied and paid in respect of the accommodation offered.
- 18. Proper Fire safety arrangements are mandatory.
- 19. Any other salient aspect of the building which the party may like to mention.

- 20. The agreement for hiring of buildings/accommodation shall come intoforce immediately after it is executed and shall remain in force for the period agreed upon.
- 21. A joint inspection team will inspect the building/buildings and submit recommendation of suitability to the Competent Authority, CUJ.
- 22. **PAYMENT:** CUJ will only be liable to pay fixed monthly charge (rent shall not in any case be more than the rent assessed by the designated authority i.e. CPWD/PWD.). Payment will be made by Cheque/RTGS/NEFT month wise on submission of bill. Monthly electricity charges will be paid as per the actual monthly reading in the meter installed in the hired building
- 23. CUJ will not be liable to pay any charge for the normal wear and tear of fittings and fixtures in the Building premises.
- 24. **PENALTY CLAUSE:** The CUJ reserves the right to check and inspect the Hostel premises on regular basis by the authorized Officials / Expert Committee. In case of any deficiency or deviation in services from the clauses mentioned in the EOI/Agreement may impose penalty on the service provider / building owner for those deficient services. The penalty will be decided by the expert committee of the CUJ and the decision will be binding on the service provider/ building owner.
- **25. TERMINATION:** The Agreement may be terminated by giving one month notice by the either party to the Agreement. However, during such notice period the buildings/accommodation along with all ongoing facilities shall remain in the possession of CUJ.

#### **PREPRATION & SUBMISSION OF PROPOSALS**

- 26. The Applicants are advised to go through the EOI document and understand the requirement and terms and conditions specified therein before submitting the bid.
- 27. Central University of Jammu invites Expression of Interest (EOI) **under two bid systems** for hiring of building for hostel accommodation for approximate 100 Boys boarders located near by or with the radius of 15KM from CUJ Campus, Rahya Suchani, Samba
- 28. Eligible and competent Service Providers, Building owners/Agencies are requested to submit their offer in prescribed application form under two bid systems in the standard formats prescribed in the EOI documents, displayed as **TECHNICAL BID** Annexure : A **& FINANCIAL BID** as Annexure :B.

- 30. All the requisite information should be filled up in prescribed form and the filled up application form, relevant information and required document should be clearly readable and all the pages of the document should be signed by authorized signatory.
